AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on 17.10.2015.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its 234th Meeting held on November 3-5, 2015. The Committee decided as under:-

"...This is a case of shifting. The CD was viewed and VT report perused. The CD shows a good building with adequate infrastructural and instructional facilities. The VT has also recommended the case. Hence, Shifting is permitted. The attention of the institution should also be drawn to clause 2 (b) of NCTE Regulations, 2014, according to which every teacher training institution has to be a composite institution, as stipulated in the guidelines issued by the NCTE hqrs vide letter dated 06.02.2015 gradually, preferably by 2016-2017."

CHHATARPUR - 471001, MADHYA PRADESH, with immediate effect for conducting D.EL.Ed. course of two years duration with an annual intake of 50 students. The institution has to be a composite institution gradually, preferably by 2016-2017.
